- Meeting Number 531 was called to order at 12:45 p.m.
- Dr. Richard Miller handled ongoing business as first on the agenda. Rules suspended and it was so moved and seconded.
- **President Altenkirch's Report** – Dr. Altenkirch reported that the City's Mayor set up the Community Committee

The Board of Trustees to meet next week to appoint a Financial Advisor and Bond Counsel

The Sale and purchase agreement with University Place School was approved by Huntsville City Board of Education, with \$4.7 million purchase price and closing about October 1, 2014. \$2.857 million will come from University Plant Fund and \$1.843 million from UAH foundation. Closing extensions to October 1, 2018 with 180 days notice. Should have the property between 2014 and 2018.

It was asked if UAH would use the building and Dr. Altenkirch said they had no plans to use the building, but to use for parking.

Patent Policy was addressed. Bayh-Dole Act (1980) and Amendments (1984). Prior to Bayh-Doyle Act, Federal government owned federally funded inventions.

Post Bayh-Dole Act, universities permitted to own inventions made under federal funding; universities obligated to have agreements with faculty and staff requiring disclosure and assignment, and develop in whole or in part utilizing university resources. Dr. Altenkirch said if you invent something at cost to the university, then it is assigned to the university. If related to your field of work, it too is assigned to the university.

Gave an example of Stanford v Roche. Faculty member made invention while at a private company. The company was sold to Roche and Roche made a product using the invention. Stanford sued for patent infringement and the Supreme Court ruled in favor of Roche. It said that the agreement with Stanford was a promise (“I agree”) to assign, whereas the agreement with Roche was authentic (“I do hereby assign”). Legal counsel to recommend change in language in Board Rule 509.

It was discussed that this could be a problem for consultants to a company, and the use of **and/or** in the clause. President pointed out that the policy is not changing, intent continues but Supreme Court has us to change word to “**hereby**” assign.

- **Dr. Vistasp Karbhari, Provost**

Coming back for final approvals for the Master of Education Degree in Differential Instruction and the BS in Economics and Computational Analysis.

Dr. Karbhari said we have approval to send the designation change to Bachelor of Science in Mechanical, Electrical, Aerospace, Industrial, etc. to ACHE. Certificate in Foreign Languages and Global Studies to go as an information item to ACHE.

Discussed briefly on-line training for Sexual Harassment.

Board of Trustees and Chancellor asked about our policy on child protection? Camp or organized events on campus. He stated we will adopt the UA Policy because it is broad and easy, and will review it as well. Dr. Karbhari stated we **must** report child abuse if we see it, because it is a criminal offense.

Diploma printing was discussed and that it will have BSN and the major listed. Card has already gone out to students.
