SCOPE AND OBJECTIVE

This report encompasses an examination of compliance of the University of Alabama in Huntsville (the "University") with applicable laws and regulations of the State of Alabama. The objective of the examination was to determine whether the University complied with these laws and regulations.

The firm of PricewaterhouseCoopers LLP conducted a financial statement audit as of and for the fiscal years ended September 30, 2007 and 2006, respectively.

<u>AUDIT COMMENTS</u>

The University of Alabama in Huntsville (UAH) is an autonomous campus within the University of Alabama System dedicated to excellence in teaching, research, and service. UAH is a public research university that offers 59 degree-granting programs, including 30 bachelor's degree programs, 17 master's degree programs, and 12 Ph.D. programs through its five colleges: Administrative Science, Liberal Arts, Engineering, Nursing, and Science.

This examination consisted of a review of overall compliance of the University with applicable Alabama laws and regulations and was performed by evaluating University procedures and testing samples of transactions. Nothing came to our attention to indicate that the University had not complied with applicable Alabama laws and regulations.
