Form Instructions

Completing the Form: On each form, fill out the institution of higher education (IHE or institution) name, the date of the report, the appropriate quarter the report covers (September 30, December 31, March 31, June 30), the 11-digit PR/Award Number (number is found in Box 2 of your Grant Award Notification (GAN)) for each HEERF grant funding stream as applicable, the total amount of funds awarded by the Department (including reserve funds if awarded), and check the box if the report is a “final report.” Institutions that expended HEERF grant funds during the calendar quarter from January 1 – March 30, 2021 are required to post the quarterly report that involved the expenditure of HEERF II CRRSAA and HEERF I CARES Act funds. Posting the Form: This form must be conspicuously posted on the institution’s primary website on the same page the reports of the IHE’s activities as to the emergency financial aid grants to students made with funds from the IHE’s allocation under (a)(1) of the CARES Act, CRRSAA, and ARP (Student Aid Portion) are posted. It may be posted in an HTML webpage format or as a link to a PDF. A new separate form must be posted covering each quarterly reporting period (September 30, December 31, March 31, June 30), concluding after either (1) posting the quarterly report ending September 30, 2023 or (2) when an institution has expended and liquidated all (a)(1) Institutional Portion, (a)(2), and (a)(3) funds and checks the “final report” box. American Rescue Plan Act of 2021 (H.R. 1319)

The committee has recommended the following for approval.

All enrolled students will receive funding, an application is not needed. We are working on the final details and verifying address and direct deposit information. The funding levels proposed are:

We will begin awarding in the next few weeks, keep in mind the following:

- You must be currently enrolled for Spring 2022
- EFC changes will only be considered as funding allows
- You will have limited time to cash/deposit paper checks **which must be mailed**
- Lost or expired checks is the responsibility of the student
- Direct Deposit is HIGHLY recommended even if you cancel later - they can be setup thru My.UAH.edu

If your financial situation has changed significantly from what is reflected on your federal income tax return (for example, if you've lost a job or otherwise experienced a drop in income), you may be eligible to have your financial aid adjusted. When there are circumstances that impact your federal student aid eligibility, the UAH Office of Financial Aid is provided discretion by the Dept. of Education - on a case by case basis and with adequate documentation - to make a re-evaluation of the data elements on the FAFSA that impact your Expected Family Contribution/EFC. The result of the re-evaluation cannot be appealed to the Dept. of Education.

The professional judgement process is referred to as an EFC/Family Contribution Appeal. The Appeal is an extensive process that requires a thorough review by the Office of Financial Aid. Your FAFSA will be selected for a process called Verification. The Verification process can result in a change in your eligibility. Your eligibility in the Appeal will be determined at the completion of the Verification process.

Your formal request is to be sent to the Office of Financial Aid at finaid@uah.edu. The request is required to be sent via your UAH email account. The request is to include an explanation of your circumstances for the EFC/Family Contribution Appeal.

If your current award includes the maximum offer already, an adjustment will not be made.

The 2021-2022 FAFSA EFC/Family Contribution Appeal utilizes the 2020 tax and wage documentation.

If you are approved or denied, you will be notified by your UAH email account.
