The Listener's License program at The Universit	y of Alabama in Huntsville	allows participants to atten	d regular credit classes y	vithout regard	

to university admittance status. Listeners are not required to take tests or satisfy attendance requirements and no academic or CEU credit is awarded. The program participants are to be passive attendees who will not be allowed to take part in class discussion, testing, etc., unless the course instructor invites active participation. Any disruption by the participant will result in forfeiture of all privileges afforded by the Listener's License. The Listener's License is issued with the understanding it is valid on a "space available" basis. Participants must have completed their junior year in high school.

Participants pay an established course fee(s), purchase a campus parking decal, and receive library privileges for the term. Participants are not eligible for campus services (Student Clinic, tutoring, counseling, etc). Only select courses are available through the Listener's License program, and courses taken through the Listener's License program may not be petitioned for credit by examination. Students under disciplinary or academic suspension from any college or university are ineligible to register. Listener's License is NON-REFUNDABLE.
