- 7. Probation Process Ms. Michelle Massey announced that the academic probation process is coming up. She indicated that we are probably going to see the highest number of dismissals since we started tracking the academic probation process five semesters ago (approximately 33 dismissal cases, across all colleges). Students are allowed to appeal their dismissals, but per the revised policy, the earliest deadline to appeal will be in April of this next semester for consideration of readmission in the summer semester. Ms. Massey said the dismissal letters will go out first and any new probation letters will go out after that. Dr. Hakkila followed by reiterating that the purpose of this policy is not to get rid of students but, instead, to know in advance that students are in trouble and to connect them with their advisors so that, together, they can develop a plan of action to rectify their situation and put them on a path to success.

8. For the Good of the Order – Regarding academic integrity, Dr. Hakkila shared the concern that there have been eight graduate students within the past two semesters that have been caught cheating while on assistantships. He explained that, in the process of dealing with these infractions, the academic integrity committee has implemented a process wherein the assistantship is terminated, and the students are notified via letters from the Graduate School that they must reimburse the university for the prorated amount of the tuition and fees beginning with the effective date of the termination of the assistantship through the last day of the semester in which the incident occurred.

Dr. Mahafza recommended conducting an "academic integrity" training or workshop for graduate students before they begin their assistantships. This aims to provide guidance on related policies and guidelines, helping them understand the core principles of academic integrity and ethics. This would also assist students in becoming more aware of various types of violations and their associated consequences.
