- Persuasion and Political Speech: This course examined elements of persuasion through modern American public discourse. Taught 1 semester. F
- Practicing the Art of Critical Thinking: This first-year-experience class focused on training students to think critically about a wide variety of different cultural and political texts. Taught 3 semesters. F
- Presidential Rhetoric: This course analyzed different genres of presidential speeches to explore how presidents wield their power. Taught 2 semesters. F
